Dear Commissioner LaTourette,

I am a New Jersey citizen, live in New Jersey and have children and grand-children who live in New Jersey. I am also a United States Army veteran, former New Jersey police officer and attorney, and President of the National American Renaissance Movement, a New Jersey non-profit corporation.

The Department of New Jersey Environmental Protection is entrusted with protecting the New Jersey environment and the environmental health of New Jersey citizens.

It is my understanding and that of our Board of Directors that geoengineering also known as aerosol spraying, also known as chem trails is occurring over New Jersey skies. We are also aware that this aerosol spraying contains nano particulates that include aluminum, barium, strontium and other harmful contents.

Please respond promptly to the following questions and produce the requested documents.

- 1. Does the State of New Jersey have written agreements or contracts or understandings with the federal government, with state governments, with foreign governments or entities or private contractors or with any organization or person to do this spraying? Please produce all documentation
- 2. What is the official policy of the State of New Jersey regarding the aerosol spraying, including nano-sized particles?
- 3. What is your understanding of the reasons for the spraying?
- 4. What is in the aerosols that are being sprayed? Please produce a list of items that are in the spray
- 5. Who is doing the spraying?
- 6. What type of aircraft are being used?
- 7. How often is the spraying done?
- 8. Is there a schedule for this spraying?
- 9. Is the spraying harmful to human health?

Is the spraying harmful to animals, birds, fish, plants, trees, water, agricultural crops, the soil?

- 10. Who or what New Jersey organization gave permission for this spraying.
- 11. When did the spraying historically begin over New Jersey?
- 12. Have the elected or appointed officials been educated on the spraying by those doing the spraying or authorizing the spraying. Please produce any educational material they received.
- 13. Are there news articles or press releases from the State of New Jersey or it's officials that describe the spraying and the policy concerning the spraying. If so, please forward.
- 14. How often does your Department monitor the content and quality of the air over New Jersey that New Jersey citizens breathe?
- 15. What is the method used for this monitoring including nano-sized particles?

- 16. Where are the monitoring locations from which the air over New Jersey that New Jersey citizens breathe is taken?
- 17. Please produce all Monitoring reports of air quality listing the components in the air and their percentages.
